

**MINUTES**  
**CITY OF PORT WASHINGTON**  
**FINANCE AND LICENSE COMMITTEE**  
**August 4, 2009**

1. Roll Call. Members present: Tom Hudson, Dave Larson and Burt Babcock. Absent & excused was Administrator Mark Grams.
2. Approve Minutes of Previous Meeting – Motion was made by Alderman Larson seconded by Alderman Babcock to approve the minutes of July 7, 2009. Motion carried unanimously.

9. Review 2010 Budget Preparation Memo – Alderman Hudson reviewed with the Committee the 2010 Budget Preparation memo from City Administrator Mark Grams.
  
10. Resolution 2009-21 (Resolution To Levy Special Assessments Against Property At 1664 Shalestone Drive) –Attorney John DeStefanis was present and reviewed with the Committee the information regarding the levy special assessments against the property. He gave a timeline as to what the City has done to bring this property to code and what the special assessment would consist of. He stated that legal fees amounted to \$8,000, City Administrator and City Building Inspector’s time involved in this project amounted to \$2,000 and the forfeiture amounted to \$5,000 for a total of \$15,000. This can be paid over five years with interest as long as Mr. Lippe owns it. If Mr. Lippe sells the property, it must be paid up in full. Motion by Alderman Larson, seconded by Alderman Babcock to approve Resolution 2009-21. Motion carried unanimously.
