

**MINUTES**  
**CITY OF PORT WASHINGTON**  
**FINANCE AND LICENSE COMMITTEE**  
**July 7, 2009**

1. Roll Call. Members present: Tom Hudson, Dave Larson and Burt Babcock. Also present was Administrator Mark Grams.
2. Approve Minutes of Previous Meeting – Motion was made by Alderman Babcock seconded by Alderman Hudson to approve the minutes of June 16, 2009. Motion carried unanimously.
3. Consider Original Operator’s License Applications – Motion by Alderman Babcock, seconded by Alderman Hudson to recommend approval of the Original Operator’s License Applications for James Blick and Joan J. Meyer. Motion carried unanimously.
4. Consider Renewal Of Operator’s License Applications – Motion by Alderman Babcock, seconded by Alderman Hudson to recommend approval of the renewal of Operator’s License applications for Diane G. Greene, Ronald Keller, Lisa B. Pauly, Marcia K. Perry, Jamie L. Price, Paul L. Jerdee, and Andrew L. Wegner. Motion carried unanimously.

Motion carried unanimously.

10. Resolution 2009-20 (Preliminary Resolution To Levy Special Assessments Against Benefiting Properties For Improvements To Sunset Road) – Motion by Alderman Larson, seconded by Alderman Babcock to recommend approval of Resolution 2009-20. Motion carried unanimously.
11. Discuss Creation Of Downtown TIF District – Mark Grams and Randy Tetzlaff reviewed with the Committee a proposal for a downtown TIF District. They outlined the boundaries for the District and projects that would be part of the project plan. Following discussion, motion by Alderman Larson, seconded by Alderman Babcock to recommend approval for the creation of a Downtown TIF District. Motion carried unanimously.
12. Discuss Budget Guidelines For Preparation Of 2010 City Budgets – The City Administrator reviewed the 2010 Budget Preparation Guidelines with the Committee. The goals will be to meet the State Levy Limit requirements and remain eligible for the State Expenditure Restraint Program. The Administrator will have Department Heads prepare two budgets, one with a 0% increase and a second with a 2% increase.
13. Consider Special Assessment Payment Plan For Trudy, LLC – Motion by Alderman Larson, seconded by Alderman Babcock to approve the Special Assessment Payment Plan for Trudy, LLC. Motion carried unanimously.
